In Person Worship Guidelines

In attempts of making our church as safe as possible, CDC guidelines will be enforced. All rules and markings are expected to be followed.

- All members will require a Health Screening Questionnaire to be completed and turned in at the temperature check desk station, prior to attendance of any in person service. This form is required to be completed the day of attending service. See Attached
- All members will be required to wear a face mask upon entering the sanctuary. Mask is to remain on and worn properly during the entire service, unless speaking from behind the approved designated area(s).
- Temperature checks are required for every one that enters the sanctuary. Social distancing should be followed at all times. A minimum of 6 ft or more will be required and are to be followed as directed during inclement weather.
- Members are expected to adhere to seating protocol. Seating is marked appropriately and will be monitored by the presiding minister with the assistance of the Ushers. Family members that are in the same household can be seated together on one pew. Otherwise, individual members are to adhere to and follow pew markings.
- Members are to enter one way through the Main Sanctuary entry. Exits
 are allowed though side doors. Please note, there will be no re-entry,
 except through the Main Sanctuary. **NO SHORTCUTS**
- There will be no face to face fellowship during or after worship.
 Members are expected to leave the building and return to their prospective vehicles.
- Church services will be limited to 1 hour.

In Person Worship Guidelines(continued)

- Sunday School will be condensed to highlights only and not to exceed 30 minutes.
- Tithes and Offerings should be sealed in an envelope and placed in the appropriated area. Please have your exact monetary amount, as no change will be given.
- Communion will be packaged in individual Ziploc bags for those who are comfortable to partake on the 4th Sunday. Communion will be available upon arrival in a designated area.
- If you have been ill, experienced any coughing, sneezing, chills, fever or have a runny nose within 1 week of your proposed service time, please do not attend church that Sunday.
- Church dismissal will be conducted from the pulpit one pew at a time. This will prevent over crowding when exiting.
- Weddings and Funeral Services will follow the same protocol, with exceptions approved by Elder James Williams only.

Note: During praise and worship we ask, please exercise restraint to remain within your designated seating/standing area. As we enter flu season, we ask that we be prayerful, cautious, and remain safe!
